


(U) The Central Intelligence Agency (CIA) Office of the General Counsel prepared an opinion on the applicability of the Anti-Deficiency Act to the National Reconnaissance Office's (NRO) incrementally-funded programs. The Department of Defense (DoD) Office of General Counsel concurred with the opinion. The opinion was attached to the Director, Central Intelligence (DCI) letter dated 24 September 1996 sent to the House Permanent Select Committee on Intelligence (HPSCI), Senate Select Committee on Intelligence (SSCI), House Appropriations Committee/National Security Subcommittee (HAC/NSS), Senate Appropriations Committee/Defense Subcommittee (SAC/DefSubCom), House National Security Committee (HNSC), and the Senate Armed Services Committee (SASC).

(U) This issue was addressed in the DCI's letter dated 24 September 1996 sent to the Congressional oversight committees.

(U) The NRO implementation of an integrated financial management system is a two-phased (near and longer term) approach. In the near term, the NRO is integrating and enhancing existing systems. In the longer term, the NRO signed a contract with American Management Systems (AMS), Inc., to acquire the Federal Financial System Program Office Desktop software. The contract was the result of a competitive procurement for commercial-off-the-shelf federal financial system software that produces auditable financial statements. Status of the implementation of these financial systems is reported in the NRO Bi-Monthly Report of Financial Management Practices (latest Report – 11 December 1996).


(U) The Inspector General of NRO is conducting an independent assessment of SETA support. Results of this assessment are anticipated in mid-to late-April 1997.

(U) "To correct deficient finar cial practices of the recent past, the NRO has set the target of having no n ore than two months of forward funding on hand by the end of fiscal year 1996, and one month of forward funding by the end of fiscal year 1997. To ensure that these goals are met and to demonstrate control of its financial operations, the committee directs that the NRO:
(a) report to the Committee is unobligated balances for all appropriations and fiscal years as of September 30, 1996, and September 30, 1997; (b) provide a listing, as of September 30, 1996, of contracts which have funding in excess of costs to be incurred through November 30, 1996; and (c) provide a listing as of September 30, 1997, of contracts which have funding in excess of costs to be incurred through October 31, 1997. In submitting these reports to the Committee the NRO will provide narrative explanations for those contract amounts exceeding target."

(U) The NRO report on unobligated balances for all appropriations and fiscal years as of 30 September 1996 is complete. With its current financial accounting system, the NRO cannot provide an automated listing of contract funding in excess of cost to be incurred through 30 November 1996. The DoD/IG and auditors are working to produce this information manually. We will, in the future, have an automated system. A report will be completed an submitted as soon as this information is available.



(U) Financial Management Automated Data Processing (ADP) Upgrades

"The Committee recommends an a iditional acquisition of ADP equipment and the development of associated software to accelerate the NRO's transition to a common accounting system. The funds provided shall also be used for the procurement of contract support software automation tools for NRO-wide application. The Committee directs the NRO to provide a report no later than March 15, 1997 detailing its plans to implement a common accounting system and other financial management upgrades."

Actions Taken or Pending to Comply with Congressional Instructions

(U) The FY 97 Defense Appropriations Conference provided the NRO with for financial management ADP upgrades. The implementation of an NRO integrated financial management system which complies with the Committee's direction is in progress. Current status of the implementation is reported in the current NRO Bi-monthly Report of Financial Management.
