Prior to the attacks of 9/11, I worked on a number of highly classified intelligence matters while I was a career attorney-adviser at the Office of Legal Counsel (OLC) at the Department of Justice. I spent two years working exclusively on intelligence and national security issues during my first tour as Deputy Legal Advisor at the National Security Council (NSC) from 1999-2000. Since 9/11, I have worked on a wide range of national security and intelligence issues, both at the Department of Justice and during my second tour at the White House, where I served as Special Counsel to the President for National Security Affairs and Deputy Legal Advisor to the National Security Staff (NSS). My time at the NSS was exclusively focused on the most pressing national security and intelligence issues faced by the U.S. government. As a Special U.S. Attorney in the National Security Section of the D.C. U.S. Attorney's Office, I approached national security issues from the criminal prosecution angle. Since my return to OLC, where I served as the head of the Office for several months, we have given advice on numerous intelligence and national security issues.

I believe that I am qualified to serve as the General Counsel of the CIA for several reasons. First, I know and understand the Office of General Counsel. From my position at the Office of Legal Counsel (OLC) at the Department of Justice, I have advised the CIA on a wide variety of legal issues over the past fifteen years. During that time, as well as during my two tours at the National Security Council, I have worked closely with the General Counsels of the CIA, other senior CIA officials, and many other lawyers at the agency. Second, as noted above in Item 10, I have developed a deep expertise in intelligence and national security law, as well as in the other types of issues faced by the Office of General Counsel, from working effectively with Congress, to litigation, to personnel matters. Third, my time at the NSC and NSS, as well as at OLC, has enabled me to develop extremely productive professional relationships and friendships with many lawyers from across the interagency community, including as a long-time member of the NSC/NSS interagency lawyers' group. The relationships that I have developed across administrations would enable me to effectively advance the CIA's interests in the interagency legal process. Fourth, I have management experience, both from my time at the NSC and NSS managing the interagency legal review of difficult issues in a compressed timeframe, and during my tenure running OLC at the beginning of 2011 and then over the past two years as a key part of the senior management team. Finally, as a lifetime U.S. government employee, I have an abiding commitment to public service and believe that I would approach difficult issues with integrity. I am committed both to the protection of our national security and to the rule of law.

I believe that congressional oversight of the Executive Branch is particularly critical in the area of U.S. intelligence activities because the classified nature of the work that the Intelligence Community conducts increases the need in our system of checks and balances for Congress to be directly engaged. The CIA must keep the Intelligence Committees fully and currently informed about intelligence activities and covert actions, including any significant anticipated intelligence activity and any significant intelligence failure, to the extent consistent with due regard for the protection from unauthorized disclosure of certain national security information. The CIA, through its General Counsel, also has an obligation to explain to the oversight committees the legal basis for the intelligence activities of the agency. If the Intelligence Committees have questions about that legal basis, it is the responsibility of the CIA, and in particular its General Counsel, to make sure that they are answered. In turn, the Committees have an obligation to ask probing questions about activities that cannot be debated in the public eye due to their classified nature.

 EXPLAIN YOUR UNDERSTANDING OF THE RESPONSIBILITIES OF THE GENERAL COUNSEL OF THE CENTRAL INTELLIGENCE AGENCY.

By statute, the General Counsel is the chief legal officer of the CIA. In 1996, Congress made the position one that is subject to Senate confirmation to enhance accountability and strengthen the oversight process. The General Counsel serves as the legal adviser to the Director of the Central Intelligence Agency and is responsible for ensuring that accurate legal advice is provided to him and throughout the CIA. The General Counsel is responsible for advising the Director on all legal matters relating to his role as head of the CIA, including his statutory responsibilities. For example, the General Counsel helps the Director in responding to congressional oversight requests, with a particular focus on explaining the legal basis under which particular intelligence activities or covert actions are being conducted. More generally, the General Counsel is responsible for providing clear legal advice and guidance to Agency officials.

The General Counsel is also responsible for efficiently supervising and managing the Office of General Counsel (OGC), which assists in carrying out her duties. OGC provides advice and guidance to employees within the CIA on a wide range of topics, including legal issues relating to foreign intelligence and counterintelligence activities, international terrorism, international narcotics trafficking, nonproliferation, law enforcement assistance, the intelligence analysis process, science and technology activities, legislative affairs, security matters, personnel issues, including government ethics, administrative law, contracting, procurement law, real estate law, environmental law, finance and budget matters, and both civil and criminal litigation, including under the Freedom of Information Act.
